THINGS TO REMEMBER!!

1. To receive your award letter before Summer School starts, your request must be received by May 08, 2017.
2. The 2016-2017 FAFSA must be on file to determine if you are eligible for financial aid for 2017 summer.
3. **Students must enroll in at least Six Credit Hours to be eligible for loans.** Loan amounts and eligibility will be determined by the Financial Aid Office.
4. **A student who's ATTENDANCE HAS NOT BEEN VERIFIED will not have their federal loan disbursed. It is imperative that you make sure your instructors are reporting your attendance to the Registrar's Office.**
5. Loans will be processed for the number of credit hours listed on the Summer School Financial Aid Request Form. **If more than 9 credit hours are listed, students will need to submit a copy of their class schedule after classes begin.** Adjustments will be made if necessary.
6. **If you have used all of your loan eligibility during the 2016/2017 academic year (Fall/Spring), your parent(s) may apply for a parent PLUS loan. If the PLUS was denied during the regular academic year and you have already received the Unsubsidized Loan, you are not eligible for those funds. **Parents may apply by going to www.studentloans.gov and log in using their FSA ID Username or email and FSA Password.**
7. As another option, you may apply for an alternative loan to assist you with the cost of summer school. To apply for an alternative loan you may access the link via the website at www.vuu.edu. From the Homepage click on the word "Financial Aid", once you are on this page, click on the word "Forms", and under Resources click on the ALTERNATIVE PRIVATE LOANS link.
8. Alternative Loans must be applied for **NO LATER THAN MAY 08, 2017.**
9. The estimated disbursement date for summer school loans will be Friday, June 5, 2017.
10. Students who were not enrolled Spring 2017 must be readmitted to the University. A readmission application can be secured from the Registrar's office by calling 1-800-368-3227 ext. 5845.



The last day to submit a Summer School Financial Aid Request Form is May 19, 2017.
