This is a summary of the annual report for the VIRGINIA PRIVATE COLLEGES BENEFITS CONSORTIUM, INC. HEALTH PLAN, (Employer Identification No. 27-1367957, Plan No. 501) for the period January 1, 2016 to December 31, 2016. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Virginia Private Colleges Benefits Consortium, Inc. has committed itself to pay all health and dental claims incurred under the terms of the plan.

The Plan has contracts with Anthem Health Plans of Virginia, Inc. and Unicare Life and Health Insurance Company, Inc. to pay all vision claims incurred under the terms of the plan. The total premiums paid for the plan year beginning January 1, 2016 and ending December 31, 2016 were \$324,457.

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was \$13,116,283 as of December 31, 2016 compared to \$12,086,859 as of January 1, 2016. During the plan year the plan experienced an increase in its net assets of \$1,029,424. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$38,969,975. This income included employer contributions of \$25,460,518, employee contributions of \$13,430,776 and earnings from investments of \$78,681. Plan expenses were \$37,940,551. These expenses included \$3,828,302 in administrative expenses, \$32,961,884 in benefits paid to participants and beneficiaries and \$1,150,365 paid to insurance carriers for the provision of benefits.
